In 2009-2010, the USC Center on Public Diplomacy has expanded its national and international reach to great effect. Since August 2009, the Center has solidified its role as a research center with the launch of no fewer than eight new projects ranging from nation branding at the Shanghai Expo to Russia's public diplomacy toward Georgia and Ukraine. CPD Fellows & Scholars CPD Research Fellows, 2009-2011

In the fall of 2009, the Center launched a new non-resident Research Fellowship program intended to support and publicize the work of scholars and practitioners of public diplomacy. Selected from a competitive pool of international applicants by a review committee, CPD Research Fellows oversee a substantive research project that yields at least two publications for the Center's publication series, CPD Perspectives on Public Diplomacy. Three fellowships are awarded each year in which each fellow serves a two-year term and receives dedicated research support from among the students at USC.



Kathy R. Fitzpatrick Professor of Public Relations, School of Communications, Quinnipiac University

Fitzpatrick is the director of graduate studies in public relations in the School of Communications at Quinnipiac University in Hamden, Connecticut. She is a senior public relations advisor, an attorney, and an internationally-recognized scholar whose research focuses on U.S. public diplomacy and legal and ethical issues in public relations.

CPD RESEARCH FELLOW PROJECT

U.S. Public Diplomacy's Neglected Mandate: Advancing Mutual Understanding

"Mutual understanding" has long been part of U.S. public diplomacy's official mandate. Yet, historical and contemporary public diplomacy practices have focused primarily on increasing understanding of the United States among foreign publics, while virtually ignoring the need to increase Americans' understanding of foreign nations and peoples. Why has public diplomacy's "second mandate" been neglected? And, more importantly, what must be done to advance mutual understanding going forward? Fitzpatrick's study attempts to answer those questions through a two-phased research study that examines issues related to mutuality in U.S. public diplomacy.



Iskra Kirova Research and EU Advocacy Officer, International Crisis Group

Kirova is a graduate of the pioneering class of the USC Master of Public Diplomacy program. She has worked for the European Commission's Directorate-General for External Relations, responsible for sectoral coordination in the field of education, training, culture and youth in the countries of the European Neighborhood Policy.

CPD RESEARCH FELLOW PROJECT

Russia's Public Diplomacy in its Sphere of 'Privileged Interest': The Cases of Ukraine and Georgia

The main objective of this project is to examine the use of public diplomacy strategies by the Russian federation in order to extend and maintain its softpower presence in what it has defined as its sphere of 'privileged interest'. Kirova's project uses the cases of Ukraine and Georgia to exemplify Russian approaches to public diplomacy in regions that have contested its influence, but that at the same time harbor large pro-Russian enclaves. It allows for the examination of the role and significance of social, cultural, linguistic and religious affiliations - central elements in the public diplomacy toolbox - in determining broader foreign policy orientations.



Cynthia P. Schneider

Distinguished Professor in the Practice of

Diplomacy, Georgetown University

Schneider, a former U.S. Ambassador to the Netherlands, teaches, publishes, and organizes initiatives in the field of cultural diplomacy, with a focus on relations with the Muslim world. For the Brookings Institution, she leads the Arts and Culture Initiative within the Saban Center for Middle East Policy.

CPD RESEARCH FELLOW PROJECT

The Impact of Arts, Culture and Media in Afghanistan and Pakistan: Implications for U.S. Policy

This project assesses the impact of arts, culture, and media in Afghanistan and Pakistan, with the goal of developing recommendations for U.S. public diplomacy policy towards each country. This topic assumes an approach to public diplomacy which focuses on empowering local voices rather than simply promoting American ideas. Schneider's research focuses on ways in which arts, culture, and media can strengthen voices of moderation as well as a sense of national identity against the Taliban incursion in Afghanistan and Pakistan. Her research draws from both urban and rural examples from television, social networking and traditional arts.

CPD Fellows & Scholars Visiting Scholars 2009-2010

As a leading research center in public diplomacy, the USC Center on Public Diplomacy has the opportunity to host a number of visiting scholars from around the world who contribute to the academic and practical fields of public diplomacy. The following three scholars were in residence at CPD during the 2009-2010 academic year.



Dr. Robert Banks U.S. Public Diplomat in Residence, 2009-11

Banks joined the Foreign Service with USIA in 1983. During his 26 year career as a public diplomacy practitioner, he has served at posts in Germany, Cyprus, South Korea, Nicaragua, Argentina and Washington, D.C. Before arriving at USC, Dr. Banks taught regional studies as the State Department Chair at the Marine Corps War College in Quantico, VA. He served twice as a Public Affairs Officer, Press Attaché, Policy and Cultural Affairs Officer.

As CPD's 2009-2011 U.S. Public Diplomat in Residence, Banks conducts research on the evaluation of public diplomacy and teaches in USC's Master of Public Diplomacy program.

During his time at CPD, Banks presented on "The Diplomatic Image in Popular Culture" and his work on evaluation of public diplomacy.

The U.S. Public Diplomat in Residence is a unique post established at USC by the Department of State in 2006.

Dr. Michael Hawes Canada- U.S. Fulbright Visiting Chair in Public Diplomacy, 2010

Hawes is CEO of the Fulbright Canada Program and Executive Director of the Foundation for Educational Exchange between Canada and the United States of America. He has been a professor of international political economy and international relations in the Department of Political Studies at Queen's University since 1985. He has published widely on foreign policy, political culture, international economic relations, and regional integration in North America and East Asia.

While visiting CPD, Hawes presented on the impact of academic exchange as a vehicle for Canadian public diplomacy and facilitated a number of round tables between Canadian and U.S scholars throughout the year.

The Canada-U.S. Fulbright Visiting Research Chair in Public Diplomacy was established in 2006 at CPD to foster greater understanding between the U.S. and Canada.

Dr. Teresa La Porte CPD Visiting Scholar, 2009

La Porte is Professor of International Communication of the Universidad de Navarra in Spain and Visiting Professor of Intercultural Communication of the Communication Politique et Publique of the Université Paris XII-Val de Marne. Her research is related to the analysis of international political news in the media and strategies of public diplomacy. From 2002-2005 La Porte directed a research project financed by the Spanish government on "Globalization and Pluralism in European Public TV," and served as academic specialist in the project, "A New Public Diplomacy for Spain," held by the Spanish think tank Real Instituto Elcano. La Porte served both as Associate Dean and Dean of the School of Communication of the Universidad de Navarra.

During her time at CPD, La Porte presented on the public diplomacy of the European Union and worked on the forthcoming publication on the topic for the *CPD Perspectives on Public Diplomacy* series.

NATION BRANDING AT EXPO SHANGHAI 2010

This project explores how countries pursue nation branding at the World Expo and how Chinese visitors experience the branded country pavilions. The project's web page provides a Media Monitor aggregating international news stories and editorials on activities surrounding the Shanghai Expo. It also includes CPD Video Conversations – video blogs featuring a number of national pavilions and exclusive photographs from the Expo. A final report will be published at the project's conclusion.



RESHAPING CULTURAL DIPLOMACY IN A NEW ERA: CONFUCIUS INSTITUTES & CHINA'S SOFT-POWER STRATEGY

This project examines the Confucius Institutes (CI) in the United States as a platform for Chinese cultural diplomacy in the context of U.S.-China relations and higher-education management. It aims to offer a framework for understanding the opportunities and challenges facing organizations of cultural diplomacy in contemporary times. The project web page provides a Media Monitor, a research bibliography and an Interactive Map featuring the CI's in the United States. A final report will be published at the project's conclusion.

Canadian diplomat Daryl Copeland outlined the premise of his 2009 book *Guerrilla Diplomacy* - that there is something vitally wrong with the way diplomacy is being conducted in the contemporary world and that diplomacy has been mistakenly sidelined, mainly by defense.

Claudia Fritsche, Ambassador of the Principality of Liechtenstein to the United States, spoke about the role of public diplomacy in government relations and the image of Liechtenstein as a global financial center.

Two officials from the U.S. Department of State - Shamila Chaudhary (Office of Policy Planning), Sajit Ghandi (Bureau of Intelligence and Research) - and Christopher Steinitz from the Center for Strategic Studies at CNA, shared their thoughts on U.S. public diplomacy toward South Asia.

JULY 21, 2010

Sesame Street: Public Diplomacy for a New Generation

Charlotte Cole, Vice President for International Education, Research and Outreach for Sesame Workshop, discussed how Sesame Street impacts childhood education and media around the globe. She emphasized the role of co-production between Sesame Workshop and the host countries, highlighting successful co-productions, most notably in Israel-Palestine and Kosovo.

A NEW PUBLIC DIPLOMACY, SEPTEMBER 14, 2009


The USC Center on Public Diplomacy hosted an event at the Newseum in Washington D.C. to consider "A New Public Diplomacy." The evening began with a panel discussion to celebrate a new book, *Toward a New Public Diplomacy: Redirecting U.S. Foreign Policy*, and a new Palgrave Macmillan book series in Global Public Diplomacy. The panel discussion was followed by a reception overlooking the nation's capital.

INTRODUCTORY REMARKS: Dean Ernest J. Wilson III, USC Annenberg School for Communication & Journalism

PANELISTS INCLUDED:

MPD Students at CPD

This section highlights activities of the USC Master of Public Diplomacy students facilitated by the Center on Public Diplomacy during the academic year 2009-10

The USC Master of Public Diplomacy (MPD) program is offered by the USC Annenberg School for Communication & Journalism in partnership with the USC College of Letters, Arts and Sciences' School of International Relations. The first of its kind in the world, the program is developing the next generation of public diplomacy leaders. The USC Center on Public Diplomacy offers a variety of opportunities for collaboration with the MPD program including CPD internships and hosting joint events. The University of Southern California was awarded the 2008 Benjamin Franklin Award for Public Diplomacy by the U.S. Department of State for the outstanding contribution to the field made by both the MPD program and CPD.



CPD Prize for Best Student Paper 2010

Melanie Ciolek (MPD '11) is the 2010 recipient of the CPD Prize for Best Student Paper. This annual prize recognizes and publicizes an outstanding contribution to the field by a graduate student in USC's Master of Public Diplomacy program. Ciolek is president of the Association of Public Diplomacy Scholars and a PD Evaluation Research Intern at CPD.

Melanie's paper selected for this year's prize was entitled, How Social Media Contributes to Public Diplomacy: Why Embassy Jakarta's Facebook Outreach Improves Understanding of the Limitations and Potential for the State Department's Use of Social Media. The paper was selected through a blind assessment by three members of USC faculty and staff.

The Association of Public Diplomacy Scholars

The Association of Public Diplomacy Scholars (APDS) founded in 2006 at the University of Southern California, is the first student-run organization in the field of public diplomacy. APDS seeks to engage public diplomacy students, scholars and practitioners in an ongoing dialogue that furthers development of the field.

In late 2009, APDS developed a partnership with CPD to feature current MPD students and APDS alumni on the CPD Blog. From 2009-10, the CPD Blog featured over 20 APDS blog posts and continues to provide a space for Master of Public Diplomacy students to interact with the greater public diplomacy community. Additionally, CPD co-hosts events with APDS and assists in publicizing their activities through regular newsletters.

PD Magazine PD is a publication of the Association of Public Diplomacy Scholars (APDS) at USC, with support from the USC Center on Public Diplomacy, USC College's School of International Relations, the USC Annenberg School for Communication & Journalism and USC Annenberg Press.
