### The Diplomacy of Sustainability: Are Global Cities the New Climate Leaders?

In a world where more than half of humanity lives in urban settlements, the role of cities in defining the parameters of everyday life is an undeniable influence, which cannot be regarded as outside the purview of international affairs. Acuto's project seeks to address the pivotal role which global cities have in articulating global, international and transnational processes through the situated urban practices we all partake in.

## U.S. Public Diplomacy and the Indo-American Relations

Graham's research project centers on the Indo-U.S. diplomatic relationship throughout the post-war period, and investigates the role (and probable failure) of U.S. public diplomacy in India. The key premise in this work is that the course of U.S. public diplomacy in India may offer a starting point to explaining precisely why Indo-American relations have historically been fraught with difficulty and remain tentative to this day.

## Exploring the Cultural Underbelly of Public Diplomacy

Zaharna's research seeks to stimulate greater awareness and knowledge of how culture influences public diplomacy and helps generate multicultural perspectives of public diplomacy. The tendency of public diplomacy scholars and practitioners has been to view public diplomacy as "culturefree," but culture is a powerful force that shapes how entities communicate as well as how publics perceive that communication.

# **CPD Water Diplomacy Initiative**

The USC Center on Public Diplomacy, through its Water Diplomacy Initiative, seeks to bring to the forefront of public diplomacy scholarship, policy and practice, the pressing issue of water access that impacts publics in every corner of our planet. During the 2011-12 academic year, CPD focused on this important topic through dedicated research, publications and event programming.

# CPD Research & Publications on Water Diplomacy



Water, essential to humankind's existence, is increasingly unavailable because of pollution, inadequate conservation programs and mismanagement of water resources. Waterrelated problems are global in scope, and although many international bodies actively support initiatives to address water issues, public diplomacy tools must be harnessed to tackle this critical topic if water-related foreign policy

objectives are to be met. This is Water Diplomacy.

While there have been a number of papers, reports and policy memos written about global water challenges and providing recommendations to address this critical issue, none have addressed this topic through a public diplomacy lens. The tools of public diplomacy are important in addressing global water issues and will enhance water diplomacy. Therefore, CPD's research focused on U.S. foreign policies related to water, development and diplomacy and on how to incorporate public diplomacy into this global priority.

# Safe Water for All Nations & Engineering Diplomacy



### CPD CONVERSATIONS IN PUBLIC DIPLOMACY, NOVEMBER 15, 2011

During this event, the USC Center on Public Diplomacy formally launched its Water Diplomacy Initiative. Naomi Leight, CPD's Assistant Director for Research & Publications and project manager for the Initiative, explained the role public diplomacy can and should play in addressing water issues. Dr. Mike Pirbazari, Professor of Civil and Environmental Engineering at the USC Viterbi School of Engineering and faculty leader for the Safe Water for All Nations (S.W.A.N) research group, discussed the need to introduce new technologies to underdeveloped countries and the ways to successfully implement them in rural regions.

#### POLICY RECOMMENDATIONS

Since the establishment of the Senator Paul Simon Water for the Poor Act of 2005, the U.S. has invested \$3.4 billion in water programs around the world. While the United States is in a strong position to confront water challenges, more must be done to maintain this leadership role. CPD put forth three public diplomacy recommendations to secure the United States' leadership in the area of water diplomacy. These recommendations were distributed at a "CPD in DC" event in April 2012 to key actors in Washington, D.C. in a report titled, *Policy Brief: Water & Public Diplomacy*. The full report is available for free download on CPD's web site. Below is a summary of the Center's three policy recommendations:

- To strengthen U.S. national interests abroad, secure strategic partners and gain influence with foreign publics, the U.S. Department of State and the U.S. Agency for International Development should adopt water diplomacy as a means to fulfill agency Priority Goal Six for fiscal year 2012-2013 and in the future.
- The U.S. Congress should fully implement the Senator Paul Simon Water for the Poor Act of 2005 in conjunction with passing the Senator Paul Simon Water for the World Act of 2012, currently being considered by the House Committee on Foreign Affairs.
- To better facilitate global water partnerships, the United States government should establish an internationally coordinated water diplomacy working group comprising all actors—governmental, nongovernmental, local, international, multilateral organizations and the private sector—to share knowledge and best practices in creating solutions to water challenges.

### Water Diplomacy: A Foreign Policy Imperative

### A CPD CONFERENCE, FEBRUARY 27, 2012

Through panel discussions and a lunchtime program with Friends of the Earth - Middle East, this conference explored the relationship between global water-related problems and public diplomacy. During the day-long conference, speakers from the World Bank, Coca-Cola, the U.S. Army Corps of Engineers, as well as a number of scholars from universities and think tanks in the United States, Nigeria, Mexico and the Netherlands, focused on the following three topics:

- Listening: Water Diplomacy on the Ground
- Implementation: Water Diplomacy in Practice
- The Future of Water Diplomacy Policy
