As you will see from this Annual Report, the USC Center on Public Diplomacy has been more productive than ever before. 






















CPD Research Fellows

The Center runs a non-resident Research Fellowship program to support and publicize the work of scholars and practitioners of public diplomacy. Three CPD Research Fellows are selected from a competitive pool of international applicants for a two-year term and oversee an original research project that is published in the CPD Perspectives on Public Diplomacy series.



Amelia Arsenault CPD Research Fellow 2012-2014

Arsenault is an Assistant Professor of Communication at Georgia State University. Her scholarly interests center on how different international and domestic actors have attempted to leverage the changing dynamics of communication networks, and the ramifications of those activities for international relations, political and social power relationships, and north/ south inequality.

CPD RESEARCH FELLOW PROJECT

Building Linkages Online: An Assessment of U.S. Public Diplomacy 2.0 Efforts In Southern Africa

This project utilizes two case studies comparing the strategic narratives put forward via social media and related new media technologies by a major power (the United States) and an emerging power (South Africa) on strategic African political issues. Each case study examines the messaging strategies put forward in the online sphere by the respective actor via content analysis; identifies the issue network involved in discussing that issue online using hyperlink analysis; and then uses quantitative and qualitative content analysis on the news and reactions posted in those networks in order to compare and uncover the directionality and depth of the connections between messaging strategies and online discourse.



Craig Hayden CPD Research Fellow, 2012-2014

Hayden is an Assistant Professor of International Communication at American University's School of International Service. His research focuses on the policy discourse of public diplomacy, the rhetoric of foreign policy related to media technologies, as well as the impact of global media representation on international relations.

CPD RESEARCH FELLOW PROJECT

Communication Power and 21st Century Statecraft

This project examines contemporary efforts of digital engagement conducted by the United States Department of State. The purpose is to probe key assumptions about the relationship between power and communication evidenced in contemporary practices of public diplomacy. Specifically, the project unpacks crucial arguments and assumptions found in the organizational discourse and usage of technology about power that are at stake in the service of U.S. statecraft in order to understand developing concepts of collaborative diplomacy and the agency of international actors implicated in the practice of digital statecraft. The project provides a theory-informed analysis that explores the underlying discursive, cultural, and technological contexts surrounding the fusion of public diplomacy and traditional diplomatic practice.



James Ketterer CPD Research Fellow, 2012-2014

Ketterer is Egypt Country Director for AMIDEAST, based in Cairo. In that capacity he oversees portfolios including higher education advising (via the U.S. State Department's EducationUSA program), scholarships and exchanges, education abroad for Americans, educational testing, English language instruction and professional training.

CPD RESEARCH FELLOW PROJECT

International Student Mobility and Public Diplomacy After the Arab Spring: The Case of Egypt

This study examines the challenges and opportunities that exist in the case of Egypt, the region's most populous and arguably most influential country, particularly in terms of educational and cultural affairs. In short, what is the current status of international education in the bilateral relationship between the United States and Egypt? What specific factors contribute to that consistently low number of Egyptians studying in the United States? What public diplomacy policies might be instituted to mitigate those factors and increase that number? Finally, what role could enhanced educational ties play in strengthening relations between the United States and Egypt? The project addresses the lack of rigorous analysis and understanding in a way that will produce results of value to public diplomacy scholars and practitioners, the international education community, and students.

The **CPD Contributing Scholars program** is designed to support CPD Research Initiatives and to create a productive virtual space for collaboration between scholars and practitioners of public diplomacy. CPD selects at its discretion non-resident Contributing Scholars whose work closely aligns with CPD research priorities. These appointments are for a renewable term of one year.

CPD International Broadcasting Initiative

During the 2012-13 academic year, CPD focused much of its work on informing the public diplomacy community about the evolution of international broadcasting in a world that is increasingly reliant on social media and related new technologies.

CPD Research & Publications on International Broadcasting



International broadcasting has long been at the heart of major nations' public diplomacy strategies as one of the most effective ways to reach international publics. Satellite technology has enabled regional and global broadcasters to transcend traditional borders and wield significant political influence. The CPD International Broadcasting

Research Initiative looked at this topic

through the lens of a traditional public diplomacy actor, the U.S. government (USG). It analyzed USG broadcasting and social media capabilities in order to inform broadcasters, public diplomats and scholars of the practices conducted and developed by the multiple arms of the BBG.

Through our conference (see next page), we showcased the range of tools, strategies, content, technologies and budgets used by international broadcasting actors, both traditional and new. Our continued research and discussions on this topic will produce recommendations about bridging broadcast and newer media, including web, mobile, and social. The project will also consider ways that platforms such as YouTube and Facebook can empower individual citizens as well as states in a new media ecology.

Ultimately, this project will provide a blueprint for public diplomacy practitioners who must build new media mechanisms to reach global publics.

Contributing Scholar Emily Metzgar on the BBG



As a CPD Contributing Scholar 2012-13 in International Broadcasting, Dr. Emily Metzgar focused her research on the Broadcasting Board of Governors and its role as a media management organization for the United States government.

Her research culminated in a publication for the CPD Perspectives on Public Diplomacy series titled, "Considering the 'Illogical Patchwork': The Broadcasting Board of Governors

and U.S. International Broadcasting." The piece analyzes each of the five broadcasters that the BBG manages, the impact of the Smith-Mundt Act, and the composition of the Broadcasting Board of Governors, and looks ahead to the potential role of the BBG in U.S. International Broadcasting and public diplomacy efforts in the future.

Emily Metzgar is assistant professor at Indiana University's School of Journalism. Her research focuses on public diplomacy, political communication and social media. She received her PhD from Louisiana State University's Manship School of Mass Communication in 2008 and is an alumna of CPD's 2009 Summer Institute in Public Diplomacy. Metzgar contributes to the CPD Blog about IB and other topics.



Events A Special LA Celebration of Public Diplomacy



On April 23, a group of Los Angeles devotees of public diplomacy and world affairs gathered for a cocktail reception at the magnificent home of Ambassador Robert Tuttle and his wife, CPD Advisory Board member, Maria Hummer-Tuttle.

Orchestrated by CPD Advisory Board Chair, Kimberly Marteau Emerson, the theme of the evening was a bi-partisan discussion of "Public Diplomacy's Growing Role in U.S. Foreign Policy." Guest speakers included former CA congressmen Howard Berman (D) and David Dreier (R), each of whom shared their perspectives on the topic. CPD Advisory Board member Mel Levine moderated the discussion that followed.

The reception, which attracted close to one hundred of LA's most prominent leaders from business, entertainment, philanthropic and education sectors such as Colleen Bell, Eli and Edythe Broad, Michael Eisner, Gil Garcetti, and Catharine Soros, also served as an opportunity to raise awareness of the Center's work. Marteau Emerson acknowledged the CPD Advisory Board members in attendance who helped shape the event and extend invitations, including Simon Mainwaring, Mike Medavoy, and Barry Sanders.

Dreier and Berman agreed that public diplomacy has never been as important as it is today. Berman cited a number of successful public diplomacy programs including the President's Emergency Plan for AIDS Relief (PEPFAR) in Africa and Southeast Asia, economic assistance programs to civil society groups in Pakistan, and a program his wife, Janis, started a number of years ago which brings together congressional spouses with spouses of ambassadors from Muslim-majority countries for social gatherings in D.C. "Doing good things," Berman asserted "is the best form of public diplomacy." Dreier shared his definition of public diplomacy with the crowd: "Outreach to explain values and interests, build understanding, and make individual connections that better lives." With three billion people in the world under age 30, Dreier's prescription for U.S. public diplomacy is to increase trade opportunities especially with new democracies, which will expand economic growth. And as CPD Director Philip Seib pointed out, "the greatest enemy of extremism is prosperity."

Towards the end of the lively and informative evening, Marteau Emerson announced the creation of the Center's Membership Program as an opportunity to stay informed about and involved with CPD. For details about the program, visit CPD's website or contact cpd@usc.edu.

The eighth annual Summer Institute in Public Diplomacy was held from July 21-August 2, 2013 and brought together 32 participants from 14 countries and organizations: African Union, Denmark, India, Israel, Japan, Korea, Liberia, Mexico, the Netherlands, Nigeria, Qatar, Rwanda, Tunisia, Turkey, and the United States. As usual, participants represented foreign ministries as well as non-governmental organizations and the private sector.

The USC Master of Public Diplomacy (MPD) program is offered by the USC Annenberg School for Communication & Journalism in partnership with the USC Dornsife College of Letters, Arts and Sciences' School of International Relations. The first of its kind in the world, the program is developing the next generation of public diplomacy leaders. The degree program is directed by Nicholas J. Cull (*pictured*) and emphasizes the roles of non-state actors,

global public opinion, international news media and international communication in the public diplomacy process. The USC Center on Public Diplomacy provides a number of opportunities for collaboration with the MPD program including support for the studentrun *PD Magazine*, other publication outlets, CPD internships, and hosting joint events.

This year, a delegation of nine MPD students — with the support of CPD, the MPD program, and others — went to China to discuss with researchers innovative approaches to the U.S.-China relationship; work towards mutual understanding through peer-to-peer engagement; and build a foundation for future collaboration between USC Annenberg and Chinese scholars.



CPD Prize for Best Student Paper 2011

Xinru Ma (MPD'13, *pictured*) was the 2012 recipient of the CPD Prize for Best Student Paper. This annual prize recognizes and publicizes an outstanding contribution to the field of public diplomacy by a first year graduate student in USC's Master of Public Diplomacy Program. Xinru's paper entitled "Beyond Economic Ties: EU in the Chinese Media," examines the perceptions of the Chinese public of the European Union.

Describing Xinru's paper, Dr. Robert Banks, a professor in the MPD program and CPD's 2009-2011 U.S. Public Diplomat in Residence, wrote that it "impresses by virtue of the sheer depth and scope of the work and her commitment not just to analyzing the perception of the EU in the Chinese media, but also to offering insightful policy prescriptions for how the EU might work to improve its standing in China, including revitalizing its use of public diplomacy." *The full paper can be read on CPD's website.*
