




STRENGTHENED THE GLOBAL PD COMMUNITY

Building a strong global PD network is crucial to advancing the field. CPD runs a successful non-resident Research Fellowship program and this spring we launched the first-ever Doctoral Dissertation Grant program supporting the work of emerging scholars from around the world engaged in public diplomacy research.



TRANSFORMED RESEARCH INTO PRACTICE

CPD continued to explore ways to transform our research into practice so that practitioners and policy-makers can benefit from our work. This year we shared our scholarship more widely than ever through multiple CPD platforms including CPD Perspectives, the CPD Monitor, CPD Policy Briefs and our allnew interactive website.





As CPD entered its 10th year, our work continued to be guided by a global vision, a drive to integrate research and practice for distinctive social impact, and a commitment to preparing the next generation of public diplomacy leaders and practitioners.

Below are the main accomplishments of this past year.



ENHANCED DIGITAL CAPABILITIES

In March 2014, CPD re-launched our completely redesigned website so readers can stay connected to changes in public diplomacy around the world, dig deeper into our original analysis and curated content, engage with the global PD community and advance their career.



EXPANDED EDITORIALLY

We broadened our web content by adding new features, such as photo essays, video interviews, an Annual Review of global PD trends and This Week in PD columns. The new Q&A with CPD series featured exclusive interviews with **Sir Martin Davidson**, CEO of the British Council, **Riva Das**, India's former Joint Secretary for Public Diplomacy and **Zhao Qizheng**, Dean of the School of Journalism at China's Renmin University and former Vice Mayor of Shanghai.



BROADENED AUDIENCE SEGMENTS BOTH DOMESTICALLY AND INTERNATIONALLY

This year, to broaden its reach to a wider, more diverse and younger audience, CPD partnered with student organizations including the Association of Public Diplomacy Scholars (APDS), the Political Science Student Assembly and others, to engage undergrad and graduate students and bring the most interesting speakers to campus.



CPD RESEARCH FELLOWS

CPD runs a non-resident Research Fellowship program to support and publicize the work of scholars and practitioners of public diplomacy. Each year, three CPD Research Fellows are selected from a competitive pool of international applicants for a two-year term and oversee an original research project that is published in the *CPD Perspectives on Public Diplomacy* series.



ELLEN HUIJGH

CPD Research Fellow 2013-2015

Huijgh is a researcher at the Netherlands Institute of International Relations, Clingendael, in The Hague and the University of Antwerp (Belgium) where she explores public diplomacy and its domestic dimension at different levels of government across the globe.

CPD RESEARCH FELLOW PROJECT

The Public Diplomacy of Emerging Powers: Insights from Indonesia & Turkey

Huijgh's project examines the roles of emerging nations Indonesia and Turkey amidst a change in the global order. With the position of these emerging powers growing rapidly on the world stage and their growth in population, Indonesia and Turkey will influence not only the way in which public diplomacy is conducted, but also that of (Western) countries which need to develop socio-cultural and politico-economic relations with them at bilateral, regional and multilateral levels. Ultimately, these global developments will also have potential effects on how public diplomacy is thought about and practiced and how it will further take shape in the future.



JAMES PAMMENT

CPD Research Fellow 2013-2015

Pamment is a post-doctoral fellow at the University of Texas at Austin, where he researches communication and diplomacy. He is author of New Public Diplomacy in the 21st Century (Routledge New Diplomacy Series), a comparative study of public diplomacy policy, practice and evaluation in Sweden, the United Kingdom and the United States.

CPD RESEARCH FELLOW PROJECT

Intersections between Public Diplomacy & International Development

This project investigates the relationship between public diplomacy and international development, establishing a common definition which bridges the two fields. As practitioners of both public diplomacy and international development are now called upon to find points of common interest, this report will highlight examples that demonstrate the diverse approaches and challenges facing practitioners at the intersection between the two fields and facilitate the conceptualization of practitioner activities at the intersection of PD and international development.



TARA ORNSTEIN

CPD Research Fellow 2013-2015

Ornstein is the Technical Officer at the Technology, Research, Education and Technical Assistance for TB (TREAT TB) Project, where she coordinates research activities that aim to improve TB diagnosis and treatment in limited-resource, high-burden settings.

CPD RESEARCH FELLOW PROJECT

The Role of New Public Diplomacy in Global Tuberculosis Control

This study aims to provide a link between global health policymakers and communities affected by the worldwide tuberculosis epidemic. With public diplomacy techniques having already been used successfully in Brazil and South Africa, there are signs of promise for assisting communities in other high-burden areas to advocate for their needs and gain international partners. In particular, this project centers on TREAT TB, which aims to add empirical evidence to growing media coverage of the role of public diplomacy in global tuberculosis (TB) control. The empirical evidence collected by this project may help more communities use public diplomacy in their efforts to obtain health service.





The CPD Contributing Scholars program is designed to support CPD research initiatives and to create a productive virtual space for collaboration between scholars and practitioners of public diplomacy. CPD selects at its discretion non-resident Contributing Scholars whose work closely aligns with CPD research priorities.



EVENTS

Bridging the Practitioner-Scholar Divide

This year's event programming continued to reflect CPD's mission to lead the field of public diplomacy with a global vision and an emphasis on integrating research and practice. Guided principally by CPD's research agenda, topics featured in our *CPD Conversations* series included America's global image, Hillary Clinton as public diplomat, Sports Diplomacy in Sochi and at the World Cup, and the Cyrus Cylinder exhibit as an example of cultural relations.





As always, we maintained a balance between scholarly analysis and practical discussion. Our practitioner-speakers included **Charles Rivkin**, former U.S. Assistant Secretary of State for Economic and Business Affairs; **Evan Ryan**, U.S. Assistant Secretary of State for Educational and Cultural Affairs; **Cameron Munter**, former U.S. Ambassador to Pakistan; **Arturo Sarukhan**, former Mexican Ambassador to the United States; **Sim Farar**, Vice Chair, U.S. Advisory Commission on Public Diplomacy; **Michael Govan**, Director of LACMA; **Timothy Potts**, Director of the J. Paul Getty Museum; **Richard Burge**, Chief executive of Wilton Park in the UK.

Our CPD Annual Conference: "A New Era in Cultural Diplomacy: Rising Soft Power in Emerging Markets," which took place on February 28, 2014 with over 100 attendees, featured a series of TED-style presentations. Topics discussed included Confucius Institutes and the globalization of Chinese soft power, the UK's GREAT Britain global campaign and dialogues through Mexican, Polish, Nigerian and Turkish film festivals. A report summarizing the proceedings of the conference was produced and includes recommendations for new approaches to cultural diplomacy in emerging markets. The report is available for download on the CPD website as are video interviews with a number of the participating speakers.




